The SPS focuses primarily on the practical problems encountered in obtaining valid and enforceable U.S. patents, as well as enforcement of patent rights after grant. The seminar encompasses lectures provided by experienced practitioners, as well as a series of workshops which provide participants with a chance to learn patent practice in a hands-on setting.

Lectures are held at the Falls Church, Virginia offices of BSKB, in the metropolitan Washington, DC area. Classes generally run from 9:30am to 4:00pm daily. Detailed class schedules will be issued prior to the start of the seminar. Planned social activities give participants the chance to interact with one another and with members of BSKB. These activities include an opening "getting to know you" reception, a two day trip outside of the Washington, DC area and a closing banquet.
