## RESOLUTION OF THE GOVERNMENT OF THE KYRGYZ REPUBLIC

On the alterations and additions of the Resolution No.346 of the Government of the Kyrgyz Republic of June 12, 1998 "On approval of the Regulation on the fees for patenting of inventions, utility models, industrial designs, for registration of trademarks, service marks, appellations of origin, and for granting the right to use appellations of origin"

Government of the Kyrgyz Republic has decided:

1. To include the following alterations and additions into the Regulation on the fees for patenting of inventions, utility models, industrial designs, for registration of trademarks, service marks, appellations of origin, and for granting the right to use appellations of origin approved by the Resolution No.346 of June 12, 1998 of the Government of the Kyrgyz Republic "On approval of the Regulation on the fees for patenting of inventions, utility models, industrial designs, for registration of trademarks, service marks, appellations of origin, and for granting the right to use appellations of origin, and for granting the right to use appellations of origin.

- in the Section I "General Provisions":

paragraph 6 shall be in the following redaction:

"6. Status of persons referred to in the paragraphs 3, 4 and 5 of Section I of the Regulation, shall be determined according to the legislation of the country where these persons have their location (residence) respectively".

Any benefits provided for in the 3, 4 and 5 of Section I of the Regulation, shall be applied to the group of persons if each of them is included to any category referred to in these paragraphs.

A group consisted of various categories of persons shall pay the fee according to the rate of one of the persons, which is maximal among other persons of this group.

Group of persons may be formed from applicants, persons for name of which the title of protection is required, owners of the titles of protection in different combinations.

Persons having the right for benefits shall submit documents confirming this right".

paragraph 7 shall be in the following redaction:

"7. In the event that licensing agreement or agreement on transfer of the title of protection is concluded, benefits for payment of fees provided for in the Regulation shall not be effective since the conclusion of such agreement";

in paragraph 10 a word "provisional" shall be deleted;

in paragraph 12 a word "applicant" shall be deleted;

- in the Section II "Inventions, utility models and industrial designs":

in second item of paragraph 4 a word "considered" shall be changed for "recognized"; The following paragraph 30-1 shall be added into this Section:
